HI Team and intervention areas

HI LATAM is exploring possible intervention in Guatemala. There are no HI staff in the country now and no local registration. A consultancy based in Honduras is underway for one year to support technical assistance activities and identify opportunities for possible future intervention. HI is providing a technical support on disability inclusion to a consortium in three countries in the region, including Honduras, Guatemala & El Salvador.

c) Geopolitical analysis

In Guatemala, 5 million people have humanitarian needs, with the highest numbers in the food security, protection and nutrition sectors. According to the UN Humanitarian Response Plan 2023, in 2022, the humanitarian needs of vulnerable people in Guatemala occurred in a complex context, influenced by the aftermath of the COVID-19 pandemic and the economic impacts of the war between Russia and Ukraine. Both factors have had a substantial impact on the dynamics of life in the country as rising prices for food, fuel and fertilizers are inhibiting full recovery.

Food assistance needs are at a record high: some 4.6 million people are food insecure and need immediate attention. In addition, some 1.9 million people have humanitarian needs related to acute malnutrition, including children under five, pregnant women and those of childbearing age, older persons and persons with disabilities. Guatemala is also a country of origin, transit, destination and return of people, refugees and applicants for refugee status, many of whom have specific protection needs.

The country has also faced some changes in the political, legal, institutional, security and governance landscape, as well as the occurrence of new extreme weather events. In the 2022 rainy season, tropical storms Julia and Lisa impacted areas already affected by storms Eta and lota in 2020.

In this context, people with disabilities in Guatemala and their families are in a situation of complex vulnerability. Data shows they have less access to education, economic inclusion and are more likely to be poor and suffer from severe health problems.



Summary of HI presence in the country

2010-2011: Closing of the Central America program and systematization of experience. This program covered Nicaragua, Honduras and El Salvador, but not Guatemala, where HI has never had any projects.

2020: Decision to explore a possible new HI intervention in Central America (StratOp LATAM 2020-2024) including Guatemala, in a context of growing humanitarian needs.

2021-2022: desk review and exploratory missions by the LATAM regional team.

January 2023: Start of technical assistance on inclusion in the framework of a consortium in Honduras, Guatemala and El Salvador (ECHO).

June 2023: Start of a local consultancy to support the development of HI mission in Central America, based in Honduras.
